# WEAPONS CONTRACT

**THIS FORM MUST BE SIGNED WHEN YOU REGISTER FOR SCHOOL EVERY YEAR.**

Guns and other weapons clearly are a hazard to safe learning environment and the welfare of human beings. This contract draws attention to the specific responsibilities of those below.

**STUDENT:**

- I agree not to bring a gun or any weapon to school or to any school event.
- I will tell my peers to seek adult assistance when conflict situations begin to get out of control.
- I will not carry another person's gun or weapon.
- If I see a gun or weapon on campus or at a school event, I will alert a staff member or parent about its existence.

**PARENT/GUARDIAN:**

- I will encourage my student to settle arguments without resorting to violence and to follow school guidelines for reporting guns and/or weapons to an appropriate adult.
- I will support the school's policies to eliminate guns and weapons at school, and will work with the school in developing programs to prevent violence.

**PRINCIPAL:**

- I will ensure that students have an anonymous way to report to any adult any guns or weapons that they see on campus.
- I will promote conflict resolution instruction for all students as part of the curriculum.
- I will communicate the school's policies on guns and weapons to all participants in the school community and focus upon the responsibilities that we all have.
- I will use the school's student leadership groups and students meetings to obtain ideas to develop a safe school environment.
- I will report all guns and other weapons violations to law enforcement officials, according to established procedures.

# ATTENDANCE REQUIREMENTS FOR STUDENTS

Regular school attendance is a critical factor for your student's success in learning and making progress toward graduation. Research indicates a strong relationship between consistent school attendance, academic success, and school completion.

Parents may be unaware of the laws requiring school attendance, or the potential legal consequences to the child and the parent of a child is excessively absent from school. Attendance at school is not only important; it is also the law. Excessive absences and/or tardies from school may constitute a violation of Oregon Compulsory Education Law and District Policy. Oregon Revised Statute 330.030 states that every parent is directed to ensure that their child attends school regularly.

Eight unexcused one-half day absences in any four-week period during which the school is in session shall be considered irregular attendance. **After 10 consecutive absences, a student will be dropped from school enrollment.**

**Excused Absences:**

- Illness or injury of the student
- Illness or death in the family which includes, but is not necessarily limited to mother, father, siblings, grandparents, aunts, uncles and cousins
- Family emergency of an unforeseen nature
- Medical or dental appointment of a student that cannot be made outside the school day and **can be verified**, except in the case of an emergency
- Obligatory religious observances of the student's own faith
- Subpoenaed court appearance
- Participation in a school approved student activity or a district approved function
- Pre-arranged absences approved by their Associate Principal, along with the prearranged form (available in the Attendance Office).

**Unexcused Absences:**

Any absence for a day or any significant part of a day for reasons other than those listed above and any absences without parent knowledge and arrangement with school officials shall be considered an "unexcused" absence. A "significant part of a day" is defined as one class period or its equivalent. **A student who is more than 30 minutes late to a class will be counted as an absence.**
